Topic ORIGINAL NARRATIVE

On 5-13-2006 I was assisting with a DUI investigation. See case #306010538 for further details. Cheryl Snow was the passenger in the vehicle I had stopped. While I was trying to gather the necessary paperwork, Snow started to interfere with the investigation. Snow got out of the vehicle and came to the back of the truck where I was talking to the driver, Cecil Tisdale. I asked Snow to return to the vehicle. She refused. She said she did not have to. I could smell the strong odor of an alcoholic beverage on her breath. She continuously interrupted me while I tried to talk to Tisdale.

I explained to her that if she continued to interfere she would be arrested. She said go ahead and arrest her. Ofc Romani was my original backup officer. He tried to talk to her and explain why we needed to talk to Tisdale without interruption. She said she did not care and came back around to where I was talking to Tisdale. She continued to make comments and yell profanities. This drew attention from people walking by.

I was writing traffic citations for Tisdale when Snow started to call to her neighbors that were walking by. She used profanity and continued to cause a disturbance. Sgt Dimeo arrived on scene and relieved Ofc Romani. Sgt Dimeo repeatedly asked Snow to stop interrupting and to calm down. Snow said she did not have to. Snow was told over and over again that her actions were interfering and she could be arrested. She said over and over go ahead and arrest her. Each time she became more animate in her actions. She started to move around and yelled how we were wasting time and we should go after real criminals.

Ofc Pietrzak arrived on scene and took over the DUI investigation. He attempted to talk to Tisdale, but Snow interrupted. I again warned Snow to not interfere. She continued. She said she had to go to the bathroom. I told her she was free to leave at anytime. She said she was not going anywhere. She said she would stay to make sure nothing would happen.

Ofc Pietrzak tried to begin the roadside sobriety tasks for Tisdale. Snow saw this and started to talk louder. This interfered with the investigation. I warned Snow to stop. She did not. I told her she was under arrest and placed her in handcuffs. Snow started to yell louder to try to interfere wit the roadsides. She was placed in my patrol car. Snow watched the roadsides from the back of my patrol car and started to yell toward Tisdale. Snow realized he could not hear her now and she stopped yelling.

Snow was transported to the St Lucie County Jail without incident.



AT APPROXIMATELY 1930 HOURS ON 05-13-06, I ARRIVED AT 1500 SE ROYAL GREEN CIR, TO ASSIST OFFICER LEVASSEUR WITH AN IMPAIRED DRIVER. LEVASSEUR STATED 911 DISPATCHED HIM TO THE AREA OF SOUTH US1 NEAR SE PORT ST LUCIE BLVD, IN REFERENCE TO A DRUNK DRIVER. LEVASSEUR LOCATED THE VEHICLE, A FORD EXPLORER AS IT WAS TRAVELING NORTHBOUND ON SOUTH US1 AT THE 10000 BLOCK. LEVASSEUR STATED THE VEHICLE WAS ALL OVER THE ROAD, SWERVING AND FAILING TO MAINTAIN ITS LANE. THE VEHICLE MADE A RIGHT TURN ONTO SE TIFFANY AVE. THE VEHICLE TRAVELED AT A SPEED OF 44 IN A 30 MPH ZONE TO SE VILLAGE GREEN DR. LEVASSEUR ACTIVATED HIS EMERGENCY LIGHTS TO CONDUCT A TRAFFIC STOP. THE VEHICLE MADE A LEFT TURN ONTO SE VILLAGE GREEN DR AND FAILED TO STOP. THE VEHICLE TRAVELED TO SE ROYAL GREEN CIR AND MADE A LEFT TURN INTO THE APPARTMENT COMPLEX. THE VEHICLE CONTINUED TO 1500 SE ROYAL GREEN CIR AND PARKED IN FRONT OF AN APPARTMENT. LEVASSEUR STATED THE DRIVER SMELLED STRONGLY OF AN ALCOHOLIC BEVERAGE AND HAD SLURRED SPEECH. UPON MY ARRIVAL, THE DRIVER WAS STANDING TO THE REAR OF HIS VEHICLE. I MET WITH THE DRIVER WHO APPEARED VERY IMPAIRED. HIS SPEECH WAS SLURRED AND HE HAD POOR BALANCE. HIS EYES WERE BLOODSHOT AND WATERY. THE DRIVER WAS IDENTIFIED AS CECIL FREDRICK TISDALE, WITH A FLORIDA DRIVERS LICENSE. HE STATED HE HAD 2 BEERS IN STUART AT A BOAT SHOW. I EXPLAINED TO THE DRIVER THAT I NEEDED HIM TO PERFORM ROADSIDE EXERCISES. THE ROADSIDE EXERCISES WERE RECORDED ON MOBILE IN CAR VIDEO MV314-06-05. THE DRIVER STATED HE WAS ON BLOOD PRESSURE MEDICINE. HE DID NOT STATE THAT HE HAD ANY OTHER PHYSICAL PROBLEMS WITH HIS BODY.

DURING THE HEAD TILT ROMBERG EXERCISE, THE DRIVER SWAYED AND DID NOT KEEP HIS EYES CLOSED. HE COULD NOT KEEP HIS EYES CLOSED BECAUSE HE WOULD LOSE HIS BALANCE. HE DID NOT KEEP HIS FEET TOGETHER. DURING THE ONE LEG STAND EXERCISE, THE DRIVER WAS UNABLE TO KEEP HIS FOOT ELEVATED. HE PUT HIS FOOT DOWN DEMONSTRATING POOR BALANCE. DURING THE FINGER TO NOSE EXERCISE, THE DRIVER DID NOT KEEP HIS EYES CLOSED, USED THE WRONG HAND, AND DID NOT TOUCH THE TIP OF HIS NOSE WITH THE TIP OF HIS INDEX FINGER 4 OUT OF 5 TIMES. HE DID NOT REMOVE HIS FINGER 1 TIME. DURING THE WALK AND TURN EXERCISE, THE DRIVER COULD NOT BALANCE IN A HEEL TO TOE POSITION DURING INSTRUCTIONS. HE STARTED THE EXERCISE BEFORE I INSTRUCTED HIM TO, AND DID NOT TOUCH HEEL TO TOE FOR THE ENTIRE EXERCISE. HE STEPPED OFF THE LINE, AND PERFORMED THE INCORRECT AMOUNT OF STEPS. HE TOOK 5 STEPS AND STOPPED THE EXERCISE. HE STARTED THE EXERCISE AGAIN, AND PERFORMED 4 STEPS BEFORE STOPPING THE EXERCISE. HE WAS ARRESTED FOR DUI FOLLOWING. I READ THE DRIVER IMPLIED CONSENT AND HE REFUSED TO TAKE A BREATH TEST. THE DRIVERS VEHICLE WAS SECURED AND LEFT IN THE PARKING LOT. HE WAS TRANSPORTED TO THE COUNTY JAIL FOR BOOKING. THE DRIVER RECEIVED DUI CITATION #2920-XAH FOR DRIVING UNDER THE INFLUENCE OF ALCOHOL. OFFICER LEVASSEUR ISSUED CITATION #8336-EKY FOR SPEEDING, CITATION #8333-EKY FOR FAILING TO MAINTAIN A SINGLE LANE, AND CITATION #8335-EKY FOR NOT HAVING HIS VEHICLE REGISTRATION IN HIS POSSESSION. HE RECEIVED CITATION #8334-EKY FOR NO PROOF OF INSURANCE.
